Operations Update: Joe Angevine

- 1. Busy with capital projects the past few months. Paving project complete. Will divert water away from scales & shop entrance during freeze/thaw.
- 2. Landfill cell construction project should be complete in the next 3 weeks. Half of a meter of tire shred to be placed to protect the liner, then a meter lift of garbage for frost protection. Anticipate final cell approval mid-late October.
- 3. Huge amount of rock and clay had to be excavated during construction, there may be additional costs. Gave them a 3 week extension to deal with it.
- 4. New Case 2500 Dozer arrived from Rocky Mountain Equipment. D6 has been cleaned up and will be sold.
- 5. A whole shipment of radioactive metal was returned. Had Secure & Tervita test metal in bales. 6 pieces of pipe were found to have naturally occurring radioactive material.
- 6. Wood grind complete, nice pile of green chip. Most of the mixed woodchip has been back hauled off site.
- 7. Floating wetlands installed and anchored. Finished install in 3 days and they are doing well.
- 8. Finalizing floating pump station project. Will be removed for winter and stored in the equipment tent. Tested the siphon system and there were a few issues with pipes bursting, all fixed now. Pond has been fully pumped down to the south ponds.
- 9. Biocap update U of C is finalizing grant proposal with the plan to build the cap in the spring/summer of 2019.

Vac Slurry Pad Update:

Joe Angevine discussed. Operational procedures have been completed and sent to Banner Environmental for design drawings etc.
