4.1 Matters arising from the previous minutes

ACTION: P. Leek will contact a local contractor to find out if they would have use for crushed glass. He will then provide this information to J. Angevine to include in the analysis.

- 4.2 Foothills Regional Landfill & Resource Recovery Centre update
 - The hydro-vac pad is nearing completion. The cost per load will be \$65/MT, discounts for municipalities will be discussed moving forward.
 - The road re-build has been completed.
 - The Request for Proposal (RFP) for the Foothills Regional Landfill & Resource Recovery Centre tipping fees has been posted and will close on Friday, August 6th, 2021.

ACTION: J. Angevine will send the proposals submitted to the TAG members to review and provide feedback.

- 4.3 Black Diamond program update
 - Black Diamond Council denied the request to purchase carts for a curbside recycling and organics program. Council requested that Administration work with the Town of Okotoks to create an implementation program for curbside pick-up of recyclables and organics.
- 4.4 Turner Valley program update
 - Turner Valley Council approved the purchase of black carts to be funded through Operational Reserves. The black carts will be used for garbage and the current blue carts will be used for recycling.
 - There will be a cost recovery/life cycle fee added to utility bills.

- The waste bylaw will be re-visited to accommodate the change in service.
- C. Beaton will provide a report to Council with potential options for managing the recycling facility.

Foothills County approved the development permit for Highwood organics located adjacent to the Cargill facility.

4.5 Nanton program update

4.6 Okotoks Waste Management Plan

- Okotoks just started the process of working with an engineering firm on updating the 2020 Waste Management Plan. J. Angevine will be interviewed on the construction and demolition waste management.
